1. Introduction

This Cookie Policy explains how VALEN & PARTNERS Sp. z o.o. (“we”, “us”, or “our”) uses cookies and similar tracking technologies when you visit our website.

This policy should be read together with our **Privacy Policy**, which explains how we process personal data more generally.

2. What Are Cookies

Cookies are small text files that are stored on your device when you visit a website. They help websites function properly, improve user experience, and provide information to website owners.

Cookies may be:

- **Session cookies** (deleted when you close your browser), or
 - **Persistent cookies** (stored for a defined period of time).

3. Types of Cookies We Use

We use the following categories of cookies:

3.1 Essential Cookies

These cookies are necessary for the website to function correctly and cannot be disabled.

They are used for:

- Website security
- Core functionality
- Cookie consent management

Legal basis: Legitimate interest

3.2 Analytics Cookies

These cookies allow us to analyze how visitors interact with the website, including traffic sources, page views, and usage patterns.

They help us improve website performance and user experience.

Examples may include:

- Website traffic measurement
- Performance monitoring
- User behavior analysis

Legal basis: Consent

Analytics cookies are only activated after you provide explicit consent.

3.3 Marketing Cookies (If Applicable)

Marketing cookies are used to track visitors across websites in order to display relevant advertising and measure marketing effectiveness.

They may be used for:

- Advertising performance tracking
- Retargeting campaigns
- Conversion measurement

- **Session cookies:** deleted automatically when you close your browser
- **Persistent cookies:** stored for a defined period or until manually deleted

The exact duration depends on the purpose of each cookie.

You can manage your cookie preferences at any time by:

- Using the cookie consent banner or settings tool on our website
- Adjusting your browser settings to block or delete cookies
- Withdrawing consent for non-essential cookies at any time

Please note that disabling certain cookies may affect website functionality.
